Minister Succeeds Edwards

A group of area women called Action For Forgotten Women, will stage what they hope will be a massive demonstration at the Women's Correctional Institute, formerly Women's Prison, 1034 Bragg Street, Raleigh, on Saturday, Nov. 16, from 12 until 3 p.m.

According to Ms. Celine Chamer, 111 Bradley Circle, Durham, a representative of the group, "The women in prison in Raleigh have been forgotten. They labor day in and day out for no pay. There is definite need for a full-time psychiatrist on the grounds. There are over 400 inmates at Women's Prison and only two telephones to use in just a three hour period of time. Arguments and fights have started there because these women want to speak to their loved ones on the outside."

More Black Students Being Suspended; NAACP Is Suing

BALTIMORE - The NAACP Legal Defense Fund filed a suit in the Federal District Court here last week charging the Prince George's Public Schools with suspending black students in substantially disproportionate numbers.

The suit alleges that black students have been and continued to be, suspended for minor violations of school rules and for activities that do not constitute a violation of the rules and regulations, and that black students are suspended for "longer periods" than white students and "without notice of charges."
