CHICAGO — Thousands of visitors from across the nation will participate in the largest black-sponsored event in the U.S. When PUSH EXPO '75 opens its doors at Chicago's International Amphitheatre, Wed., Sept. 24 through Sun., Sept. 28, for the 7th Annual Operation PUSH Business and Cultural Trade Exposition. Focusing on the critical effect of the current economic condition on the American family, Rev. Jesse L. Jackson, National President, Operation PUSH, designated "Save the Family" as the theme of this year's Expo. Through a series of meetings and workshops, national business, labor, government and media leaders will seek ways to alleviate financial pressures on the family and assure the economic survival of the wage earner and the business entrepreneur. The primary purpose of the five-day exposition is to provide an opportunity to showcase black businesses. Says 200 Principals Affected

ANNISTON, Ala. — Asserting that "we have given the foxes full charge of the hen house," the director of the National Education Association's Teacher Rights program charged in an address to be delivered here last Thursday that prejudiced school boards have been mainly responsible for the sharp decline in black principalships in 17 Southern and border states. Samuel B. Ethridge, speaking before the Southern Christian Leadership Conference, emphasized that "the North is guilty too" in respect to black educators. For example, Massachusetts, Connecticut, and Wisconsin all need at least 80 percent more black (See SAYS BLACK, P. 2)

Relatives Pleased By Jury

A few hours after a jury of her daughter's peers had handed down a not guilty verdict, Mrs. Jessie Williams, the mother of JoAnne Little, sat and spoke openly of the plights that she had encountered while her daughter was on trial for her life.

The Williams family is comprised of nine children and they all expressed their gratitude for their sister's acquittal. "Everyday that I would come home, this (the trial) was always on my mind," related 11-year-old Mike Williams, Ms. Little's extremely bright young brother. Mike and his younger brother, Lyndell Williams, age eight were retained in their grades at the end of this school term.

"Something should and something will be done about this situation. It's a shame that the school teachers acted this way. But I couldn't do anything about the problem because I was more concerned for the life of JoAnne," said Mrs. Williams, surrounded by members of the family.

"You know," Mrs. Williams started off, "Beaufort County is really a nice place, just like Raleigh, but it's the people in that place that counts."

Referring back to that moment in the Wake County Courthouse when the jury returned to the courtroom with the verdict, Mrs. Williams tried to remember her feelings. "I was real nervous at one point, but then a picture, a voice came to me and said, don't worry... and then I heard it, not guilty."

Mary Brooks, an aunt of JoAnne's, and Mrs. Williams' sister said, "My trust was always in the Lord, God is over the judge and the jury, and anyone, they must act through Him."

Mrs. Brooks, along with her husband, Richard, are very religious folk. They say that they attend church regularly and don't frequent clubs or joints.

"That jury showed that they believed in treating people as people," Mr. Brooks said.
