A decision to uphold the disciplinary committee could hinder Ms. Little's effort to gain parole, though Ratliff said that it would not be an absolute, determinitive factor in her requests for parole.

Superior Court Judge E.
Maurice Braswell rendered invalid Tuesday murder indictments against two black men, charged in the murders of two Johnston County white men after calling white men, after calling the indictments "gross irregularities" in the handling of jury selec-tions by court officials in the county

The judge made it clear, however, that the charges against the men for the alleged June 3 murders of a young police officer and a Benson truck driver had not been dropped and declared that a new grand jury could re-indict them at any time
