Proposed That Alligator River Structure Bear Name of Outstanding Leader of Area

Joining hands with their neighbor board in Tyrrell County, the Dare County Board of Commissioners Wednesday by resolution unanimously adopted, called on the State Highway Commission to name the proposed Alligator River Bridge in honor of Senator Lindsay C. Warren. The action follows a unanimous request from Representatives of the Seven Counties of the Second District, who consider it fitting that this recognition be given a man widely acclaimed for his tremendous contribution to the advancement and welfare of the region.


Mr. Warren, who represented the First District in Congress from 1925 to 1941 when he resigned to become Comptroller General of the United States by request of President Roosevelt, has been a consistent worker for road improvements in the isolated areas of his district since the beginning of the highway movement the area united under Mr. War-

ren's leadership. During his tenure in Congress, Mr. Warren brought about legislation giving Federal Recognition to Fort Raleigh, making possible the establishment of the Lost Colony; the establishment of the Wright Memorial at Kill Devil Hills; the creation of the Cape Hatteras National Seashore. He raised his voice continuously in behalf of more bridges, better bridges in eastern Carolina.
