"On 8 February 1960 I wrote you concerning our plans for dredg-ing Oregon Inlet. At that time the controlling depth across the outer bar was 8.6 feet, too shallow to permit using the hopper dredge HYDE: therefore, we planned to accomplish the work by using a pipeline dredge.


