

Social security is "not something for nothing." In the long run, the value of the worker's contributions will just about equal what he will get back in payments. In the meantime, he has had not only protection against possible death but also disability protection.

At present the trust fund has a balance of about twenty-two billion dollars, with interest on securities being over one-half billion a year. This, along with future income from covered workers, is expected to be sufficient to meet all expenditures.
